The PhD Admissions Committee would greatly appreciate your answering each of the following numbered questions on a separate sheet of paper. We would also appreciate your being as specific, detailed, and candid as possible. We recognize that you may not have adequate information about the candidate to answer all of the following questions; any unanswered questions will be treated as such.

1. Would you be willing to tell us something about yourself? For example, any information you could provide about your academic background, research interests, and your knowledge of what is needed of a doctoral student to succeed at the Stanford Graduate School of Business would be greatly appreciated.
2. How long and under what circumstances have you known the applicant?
3. Name up to three students you know who are in a similar PhD program at Stanford or a comparable institution and compare the applicant to them.
4. Give an example that illustrates the applicant's communication skills.
5. Give an example that demonstrates the applicant's creativity and/or originality of thought.
6. Give an example that illustrates the applicant's perseverance (For example, this might arise in dealing with adversity in a general context or in achieving a deep, understanding of an issue or phenomenon in an academic context.)
7. What else should we know about the readiness and potential of the applicant to succeed as a doctoral student here and, ultimately, as a professor? (For example, relevant information includes the applicant's achievements in course work, initiative, aptitude for independent thinking, capacity for research, and motivation for doctoral study. Specific examples are more compelling than general comments.)

This section seeks your overall comparison of the applicant relative to other potential applicants. If this section is not filled out completely, the applicant's chances of being admitted into the program may be reduced.
